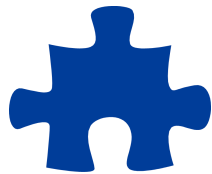

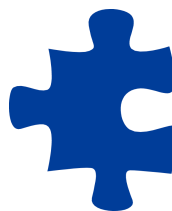

### Deadlines and Timelines

All applications must be postmarked, faxed, e-mailed, or hand-delivered by March 30th, 2012. No exceptions will be granted. All exhibitor spaces will be awarded at the discretion of the co-sponsors of the 2012 Children's Justice Conference. Acceptance notifications will be released on April 16, 2012. Submission of this application does not guarantee a spot in the 2012 Children's Justice Conference Exhibition Hall. Individuals that are not chosen for the conference exhibition hall, or those organizations that do not wish to reserve an entire exhibit space are welcome to send promotional materials to the Exhibitor Representative for display on a shared table during the main conference for a small fee of \$50.00. The deadline for this display option is March 30th, 2012. Please limit display materials to 2 items. All checks must be received by May 1, 2012. Failure to meet deadlines may result in forfeiture of exhibit spot.

### Exhibiting Fee

\$250 per each 6 foot table. This fee is waived for non-profit organizations and government agencies. **Please make all checks payable to the Wyoming Supreme Court.** Mail all checks to the address given below. If you have not enclosed your check, an invoice for \$250 will be sent to the above noted address, care of the above noted individual.

Tables will include one tablecloth, two chairs, and one acrylic 5 by 7 sign-holder with the organization's name, as given above. Fee also includes attendance to beverage breaks for 2 individuals.
